Dr. Leathers then recognized Amy Sublett and Gary Jungerman from the Central Workforce Board for the exemplary work they have done to be removed from substantial violation and have successful regional operations.

**Legislative Update:** Gerren McHam provided the Board an update on activities from the 2022 Missouri legislative session.

Local WDB Presentation: Sally Payne, Director of the Ozark WDB, provided an overview of projects and activities in her region.
