The above numbers are the actual class sizes at enrollment for the last five years of our program. We are currently in our eighth year of the program. We have a 100% job placement rate showing our graduating students have either secured jobs in their field or have been accepted into a program to further their education.

Provide a rationale for proposing this program, including evidence of market demand and societal need supported by research:

As the baby-boom population ages, the overall need for healthcare services is expected to increase. Licensed Practical Nurses will be needed in residential care facilities and in home health environments to care for older patients. The Bureau of Labor and Statistics projects a faster than average job growth until the year 2024. According to a February 2017 Workforce Investment Board report, the average monthly job postings over the last 12 months in Southwest Missouri for LPNs is 81 and average monthly hires is 58 showing the demand for LPNs is outnumbering the pool of qualified applicants.
