Program Accreditation



Institutional Plans for Accreditation:

Missouri Western State University definitely intends to seek accreditation for the Master of Social Work from the Council on Social Work Education (CSWE).

To this end, a MWSU work group has met multiple times with Ms. Anna Holster, an accreditation officer for CSWE, to clarify faculty requirements and seek her advice regarding submission of the "Candidacy Eligibility Application" and "Benchmark One" materials.

MWSU has delayed submitting its initial application until the CSWE changes in accreditation requirements were approved in June 2022. Benchmark One materials may be submitted any time post-January 1, 2023

The Office of the University President, as well as the Provost and Vice President for Academic Affairs, has made a commitment to support the \$10,000.00 price tag, up front, that is required with MWSU's initial submission of its letter of intent and candidacy eligibility fee to develop an MSW program for accreditation. (This would be due in State One, prior to the enrollment of MWSU's first cohort of MSW students.)

A commitment that the university will support the minimum of an additional \$17,550.00 costs associated with Stages Two and Three of the CSWE accreditation process Commissioner visit I fee [\$5,000.00] Commissioner visit II fee [\$5,000.00] Additional commissioner visit fee [\$2,550.00] Initial accreditation fee [\$5,000.00].

Missouri Western State University's BSW and MSW programs would be accredited separately until the MWSU Master of Social Work program earns full accreditation (i.e., which involves three stages). After this point, the two accreditations would be aligned.

All students admitted to the MSW program at any time during the academic year MWSU files its candidacy eligibility and institutional intent WOULD be considered as receiving an accredited degree upon their graduation.
