Toward that end, Northwest's program stresses the importance of the successful candidate's ability to apply cognitive, psychosocial, moral, and social-cognitive developmental theories, as well as comprehensive guidance program management, in the school setting. Additionally, major elements of the program are development and refinement of individual-, small- and large-group counseling skills, as well as the refinement of guidance skills.

Therefore, faculty collaborates consistently and efficiently with professional school counselors in the field, their respective schools, and school counselor professional organizations to provide the school-counselor-intraining realistic professional experiences and a network of professional resources.

This program will serve clinicians and teachers who may already have state licensure. This program will lead to certification in school counseling through DESE.

The goal of the College of Education and Human Services is to continue expanding services to meet the needs of graduate students in the service area while maintaining high standards of quality. Each department full-time faculty is qualified as graduate faculty at Northwest and is committed to supporting extended campus programming and developing procedures for identifying and developing a high-quality pool of part-time graduate instructors. An educational structure has been put into practice where the part-time instructors are on campus for an annual institute. They are then included in a small learning community led by campus faculty and made up of others instructing the specific course through the use of eCompanion. This process is on-going. The University has also committed to increasing full-time faculty who may be located closer to the extended site as program growth occurs. A coordinator is located at the extended site to better meet the needs of the local students, district, and community.

Adjuncts are included in on-campus professional development in addition to the specific provisions provided for them in the annual institutes and small learning comunities.

It is Northwest's desire to integrate part-time faculty into the culture of graduate education, its resources, standards, and level of teaching expertise expected by the University of its graduate faculty. Regular department faculty will be significantly involved with the professional development provided for the adjuncts. This involvement may occur face-to-face, via ITV, by mentoring visits, on-line threaded discussion, etc. The attention to the detail of who actually delivers the course work is greatly appreciated by students. By offering extended campus programs in graduate education, Northwest will meet both the demands for access and the demand for quality.

Support Services: Describe how the institution will ensure that students at this site will be able to access services such as academic support, library, computing, and financial aid, as well as other administrative functions, at a level of quality comparable to that of on-campus programs.

### Student support services, such as:

Advisement – Advising will be provided at the site by the respective site coordinator, a full faculty advisor on-site, a full faculty advisor via telephone/email, and through interaction with Outreach Education staff.

<u>Procuring Books – A procedure has been put into place for ordering books through the Campus Bookstore. Students may also order books through other means, such as internet sources.</u>

Library Access – Students have access to the Northwest Library which is supported by a high level of technology. Instruction will be given by library staff to students, adjuncts and faculty on how to use the library to the maximum benefit. Other specialized reference resources will be provided to the extended site of delivery. Students and Education Practitioner Faculty members also have access to Mobius – the combined collections of Missouri libraries in one on-line catalog. Other library resources include: research strategies, research guides, databases, on-line resources, lists of useful websites, article searches, webliographies, plagiarism detection assistance, and much more.

Technology – The CITE Office will supply technical support for eCompanion as an assist to all courses to aide in the delivery and ongoing contact with students in the field. Each ITV site is also staffed with a technical assistant who is available for ITV classes.

Financial aid staff are eager to assist graduate students in any way possible.

The Graduate Office staff are also available to assist students with concerns.

### 6. Any Other Relevant Information:

Although the school district is the location of the program as well as the employer of the prospective students, it is a program offered and controlled by Northwest Missouri State University. ### Building Use Agreement

This Building Use Agreement ("Agreement") is made and entered this 19th day of September 2014 by and between the Independence 30 School District, 201North Forest Avenue, Independence, MO 64050 ("ISD") and Northwest Missouri State University, 800 University Drive Maryville, MO 64468 ("Northwest").

WHEREAS, Northwest needs classroom space for holding graduate classes; and

WHEREAS ISD has agreed to allow Northwest to use its classroom space for Northwest's <u>M.S.Ed.</u> <u>Educational Leadership K-12. M.S. Ed. Reading and Educational Specialist graduate degree programs provided that the terms set forth in this Agreement are met.</u>

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:

- ISD agrees to let Northwest use its regular classroom space, when classroom space is available in the sole discretion of ISD's Superintendent or his designee, for holding class for the following graduate programs: M.S. Ed. Educational Leadership K-12, M.S. Ed. Reading, and Educational Specialist. Northwest may use classroom space upon approval by ISD's Superintendent or his designee at any of the following three locations: Independence School District Administration Center (201North Forest Avenue, Independence, MO 64050), Truman High School (3301S. Noland Road, Independence, MO 64055), or William Chrisman High School (1223 N. Noland Road, Independence, MO 64050).
- 2. The ISD Superintendent or his designee is the contact person for ISD and the Outreach Director is the contact person for Northwest. The ISD Superintendent or his designee and Northwest's Outreach Director will coordinate the details of Northwest's usage of classroom space at the three ISD locations, including dates, timeframes, parking, appropriate entrances and exits for Northwest's students and faculty, etc.
- 3. This is a nonfee agreement and Northwest agrees to abide by all the terms and conditions of use described in

this Agreement.

- 4. Northwest agrees that it will not use the premises for any unlawful purposes, and will obey all laws, rules, and regulations of all governmental authorities while using the above-described facilities.
- 5. Northwest agrees that it will not use the premises for any purpose that is contrary to the mission, purpose, belief, or Board policies and regulations of ISD.
- Northwest, its employees and its activities are protected from causes of action under Missouri law and all other courts of competent jurisdiction by the State Legal Expense Fund as described in Missouri Revised Statutes
  - 105.711. This fund is administered cooperatively by the Office of Administration and the Office of the Attorney
  - General. The limits of the fund are those found in the sovereign immunity law of the State of Missouri.
- 7. Northwest agrees that it is responsible for its own acts and omissions and that, subject to all applicable defenses, it shall be liable for payment of that portion of any and all claims, liabilities, injuries, suits, and demands and expenses of all kinds that may result or arise out of any alleged wrongdoing or neglect caused or alleged to have been caused by Northwest, its officials, employees, agents, or students in connection with

Northwest's usage of ISD's classroom space under this Agreement. If any third party makes a claim or brings any

action, suit, or proceeding against ISD that alleges any wrongdoing or neglect caused by Northwest, ISD will promptly notify Northwest of the third-party claim and permit Northwest to participate in defense of the claim; including the investigation and settlement of the claim.

- 8. Nothing in this Agreement shall constitute any waiver of ISD's sovereign immunity pursuant to Missouri law,
  - including but not limited to Section 537.600, et seq., of the Missouri Revised Statutes.
- 9. Northwest agrees to be responsible for returning to pre-use condition all classroom facilities that it uses.
- 10. The term of this Agreement is from January 1,2015 through December 31,2017.
- 11. This Agreement may be cancelled unilaterally by the District for any reason with 120 days written notice to

Northwest's contact person.

- 12. Northwest agrees that it will not assign any of its rights under this Agreement and any such assignment will void this Agreement at the sole option of ISD.
- 13. This document contains the entire agreement of the parties and supersedes all prior written or oral agreements relating to the subject matter.
- 14. Missouri law governs the subject matter of this Agreement.
