Specific Population Characteristics to be served:

Courses within the nursing program have strict requirements about the quality of work that is considered to be passing, and the program itself allows very limited opportunities for repeating work before a student is dismissed from the department. Students who are dismissed from nursing later in the program face a difficult situation in which considerable time, effort, and money have gone into earning credits that may be of limited use to them in most other majors. It is for the benefit of these students that we have created an alternative degree program.

These students are allowed to add to their existing background in healthcare numerous courses in business-related fields so that they are prepared for careers in the management of healthcare.

Major HEALTHCARE MANAGEMENT

Regulations that are outlined in the Nursing Student Handbook specify the quality of work within courses that is considered to be acceptable and also the limited opportunities for repeating required courses before a student is dismissed from the nursing program.

Students who are dismissed from the nursing program at a relatively early stage may be able to use their credits in nursing as electives as they seek a different major at William Jewell. However, students who are dismissed later in the nursing program face a difficult situation in which considerable investment has gone into earning credits that cannot be used toward a major in nursing.

Under the following conditions, a student who is dismissed from the nursing program will be eligible to attempt to earn an alternative degree from William Jewell:

- The student has earned a minimum of 30 hours in residence at Jewell.
- The student is on a traditional curricular track (rather than an accelerated track) in nursing.
- The student has completed successfully (with grades of C- or better) a minimum of 18 hours that can be counted toward requirements for the major in NUR.
- At the end of the term during which the student was dismissed from nursing, the student will have been on a track that puts them within one year of completing the BS degree with a major in nursing.
- The student has expressed interest in pursuing this
 alternative degree, has been recommended for the
 alternative degree by the chairs of the Department of
 Nursing and the Department of Business & Leadership,
 and has received approval for the alternative degree
 program from the Provost.

The alternative degree will be a Bachelor of Science degree. The associated major in Healthcare Management will have the requirements listed below.
