

# Tab 3 Governor's Budget Recommendations

Coordinating Board for Higher Education January 21, 2020

#### **BACKGROUND**

This informational item provides an update on the FY 2021 budget process, including the Governor's recommendations for higher education funding.

#### **CURRENT STATUS**

During fall of 2019, the Coordinating Board submitted funding recommendations for Missouri higher education and workforce development to the Office of Administration within the Governor's office, the Missouri House of Representatives and the Missouri Senate. Each year in January, the Governor initiates the formal appropriation process when he announces his funding recommendations as part of the State of the State address.

On January 15, 2020, Governor Parson released his budget recommendations for all of Missouri state government, including those programs that are part of the Department of Higher Education and Workforce Development. Attached to this agenda item is a detailed summary of the appropriation recommendations relating to higher education and workforce development.

#### **NEXT STEPS**

MDHEWD will continue to monitor budget developments in both chambers. Hearings before the appropriation committees of the legislature are scheduled for the month of February. At those hearings, staff will present information about the appropriation recommendations of the CBHE and the Governor and will answer questions posed by legislators. Staff will also meeting with members of the legislature to provide ongoing information and support during the decision-making process
