

# Tab 12 Metropolitan Community College Redistricting Committee Appointments

Coordinating Board for Higher Education September 15, 2021

### **BACKGROUND**

Section 178.820.4, RSMo, requires that "if during the period between publications of decennial census figures the area of a district is increased or decreased, a new plan shall be adopted within one year thereafter or the trustees shall be required to run in the district at large."

Metropolitan Community College (MCC) increased its taxing district during the April 2021 election. As a result, MCC must complete the redistricting process before the April 2022 election. The redistricting process for MCC is the same as the process for other community colleges with subdistricts, but is occurring on a different timeline due to the fact that MCC expanded its taxing district.

The process provided in statute is as follows:

- 1. The affected community college district board of trustees must vote to adopt a resolution calling for the formation of a redistricting committee. (§ 178.820.2, RSMo)
- "Upon adoption of the resolution, the secretary of the board of trustees shall forward a certified copy [of the resolution] to the CBHE with the request that the redistricting committee be appointed in order to divide the community college districts into at least two and not more than six subdistricts for the purpose of electing trustees" (§ 178.820.2, RSMo)
- The board of trustees appoints three residents within the affected district to the redistricting committee (§ 178.820.2, RSMo)
- The CBHE appoints three residents within the affected district to the redistricting committee (§ 178.820.2, RSMo)
- 5. The redistricting committee then meets and adopts a redistricting plan (§ 178.820.2, RSMo)
- 6. Once the plan is approved by a majority of the redistricting committee, the committee forwards a certified copy, via the board of trustees secretary, to the CBHE for approval or disapproval (§ 178.820.4, RSMo)
- 7. "The CBHE shall approve any redistricting plan in which the population of any subdistrict divided by the number of trustees to be selected therefrom substantially equals the population of any other subdistrict divided by the number of trustees to be elected therefrom" (§ 178.820.4, RSMo)
- 8. "If the plan is not approved, then it shall be returned to the redistricting committee for revision and resubmission" (§ 178.820.4, RSMo)

### **CURRENT STATUS**

The MCC Board of Trustees adopted a resolution creating the redistricting committee, appointed three members to the redistricting committee, and submitted the names of five individuals for CBHE consideration, of which the CBHE must appoint three to the committee. See Attachment A.

The biographical information for each nominee is provided in Attachment B. In summary, the MCC Board of Trustees nominated the following individuals to their redistricting committee, of which the CBHE must choose three:

### **NEXT STEPS**

After selection of appointees to the redistricting committee today, MCC will work with its vendor to create a redistricting plan. MCC will take that plan to the redistricting committee for a vote. Once approved by the redistricting committee, MCC will submit the plan to the CBHE for approval at or before the March 2022 regular meeting.

### **RECOMMENDATION**

Based on DHEWD's review of the candidates' backgrounds and in the interest of providing balance to the redistricting committee, the Department recommends the CBHE vote to appoint Marjorie Williams, David Disney, and Greg Baker to the MCC redistricting committee.

### Gregory D. Baker

A native of Kansas City, Missouri, and a Vietnam-era veteran, who served in the Air Force strategic air command, Baker received a B.A. in Psychology from Rockhurst University (Kansas City, Missouri) and a M.A. in Public Administration from the University of Kansas.

Formerly, he served as City Manager for the City of Damascus in Damascus, Oregon, Executive Director of the Blanchet House of Hospitality, the largest private owned and operated homeless shelter in the state of Oregon, briefly served as President of the Negro Leagues Baseball Museum, and seven years as the assistant city manager for the City of Kansas City, Missouri, spurring numerous initiatives to make the city more vibrant and maximize efficiency in city government. Prior to that, Baker, a true entrepreneur, served as president and CEO of LeadTeam LLC, a start-up leadership and marketing consulting firm and was vice president of Community Leadership with Missouri Gas Energy. He is currently founder and a partner with Commonwealth Consulting LLC.

As the founding executive director of Kansas City's Minority Supplier Council, he worked with top CEOs to connect more than 125 mainstream corporations and 185 minority firms. Those connections increased business revenues from \$1.8 million to more than \$467 million and stimulated new employment over a 15-year period.

In addition, Baker was the manager of community and international development with the Kansas City Chamber of Commerce and worked as a Labor Relations/Equal Opportunity Officer in the Department of Human Services in Washington, D.C

Baker's civic leadership is unprecedented. He served as Chairman of the Minority Business Capital Corporation's Board of Directors, and as an active member of the Rockhurst College Board of Regents, President of Verona Hills Homes Association, Downtown Community Improvement District and the EDC Business Retention Committee, Board Member Mental Health Association of Oregon, Catholic Charities of Portland Oregon, and The Children's' Center of Oregon City, Oregon. He served as the President of Kansas City Consensus and Co-Chaired the Race Relations task Force.

His past board memberships include the National Minority Supplier Development Council, Kansas City Consensus, Metropolitan Energy Center, Truman Medical Center, Alvin Ailey, Citizens Association, Project Equality, Metropolitan Community Colleges, Leukemia Society and Junior Achievement.

Known for his commitment to making a positive difference within the Kansas City community, Baker has received numerous awards including the Center of Creative Leadership Award (1992), National Eagles Award for Outstanding Leadership (1994) and the Junior Achievement Up & Comers Award and *The Kansas City Globe's* 100 Most Influential Blacks in Kansas City (1994). In addition, as the lead singer of Bake and the Tenderhearts, he won an Emmy Award for Vocals in the KCPT documentary, *Remember Me KC*. He was recognized with the National Peace

The results included obtaining over \$15 million in stormwater, road and other infrastructure funding through complex and varied sources that included the federal budget, Brownfields and economic development sources at the federal, state and local levels. The City as an incentive to Butler also financed the construction of a 1,000 car garage known as the West Bottoms Garage. The scope of work included the negotiation of sale-leaseback arrangements with the Planned Industrial Expansion Authority which financed the Butler garage and issued revenue bonds for redevelopment of the Butler World Headquarters improvements.

- Hearst-Argyle Stations, Inc. Representation of Hearst-Argyle in the development of a headquarters building and broadcasting facilities for KMBC-TV in Kansas City that included acquisition of headquarters site, negotiation of state and local incentives, preparation of construction and development agreements, land use decisions and business association covenants and restrictions.
- Metropolitan Kansas City Performing Arts Center. Representation of the Metropolitan Kansas City Performing Arts Center in the development of its \$320 million state-of-the-art performing arts center in downtown Kansas City. The project was developed and financed in accordance with Missouri's Chapter 100 abatement program and involved negotiation of property tax exemption and payments in-lieu-of taxes, industrial revenue bond documents and negotiation of a Grant Agreement with the Kansas City, Missouri School District. Project was also developed with assistance of Development Tax Credits and involved negotiation with the Missouri Department of Economic Development, preparation of application and related documents.



- **Hispanic Economic Development Corporation/Zimmer Development Company.** Representation of the developer on an industrial development project on Kansas City's west side. The development was begun by Zimmer Development Company pursuant to various city and federal requirements keyed by federal grants and a Section 108 loan totaling \$14.2 million to the City of Kansas City. The project is now completed and is located on old railroad property adjacent to Southwest Boulevard. Kansas Citybased DST owns and operates a massive mutual fund mail center on the site in a series of redeveloped buildings and in the renovated Union Station Roundhouse on the property. The property was blighted by industrial-related environmental problems and is considered to have historical value by the State of Missouri. The scope of work required the selection of tax incentives and the negotiation of Brownfields and other incentives from the City of Kansas City in the State of Missouri. Otherwise, the project was financially unfeasible. The scope of work also included the negotiation of Section 106 and environmental remediation plans with the State of Missouri. Other issues included MBE and WBE requirements and the Uniform Relocation Act.
- Union Hill TIF. Representation of the Developer in the Union Hill area of Kansas City, Missouri, on a mixed-use project that included office, housing and hotel developments. The construction of infrastructure and acquisition of blighted property was financed by a bond issue of the Tax Increment Financing Commission based upon PILOTS generated by the general neighborhood and a Super TIF approved by the City on a hotel on Main Street. Significant benefits would have been lost to the developer if the approval had not been secured in a timely fashion. Our representation was critical to several public-private partnerships and the assistance of Kansas City's large business corporate community played a vital role in the success of the project.
