



MoTax

- Leverages IRS Volunteer Income Tax Assistance (VITA) program
- VITA
 - IRS certified volunteers
 - Efile, Direct Deposit
 - Everything but inventory and depreciation
- 2003
- Free Tax Prep

MoTax

• Build trust, then educate

- ~10,000 returns prepared
- ~\$6.5 million refunds

MoTax 2.0

Facilitated Self Assistance (FSA)

Individuals prepare their returns with volunteer assistance

Responsibility shifted to client
