### Certificate

After completion of the certificate courses the student will be able to:

- Understand how the U.S. Constitution and Missouri Statutory Law specifically pertain to public safety and the law enforcement career field.
- Identify major issues in ethics, domestic violence and human behavior, and apply intellectual and practical tools to analyze those issues.
- Identify common problems in health, fitness and nutrition that apply to the public safety career field.
- Develop a personal physical training regimen to prevent and minimize health problems that are common among public safety professionals.
- Understand and apply elements of defensive tactics that pertain to public safety and the law enforcement field.
- Understand and apply traffic and vehicle regulations, investigate traffic accidents, complete accident reports and diagrams, and enforce pertinent traffic laws.
- Acquire the requisite handling, maintenance, and marksmanship skills in the use of handguns and shotguns, for the performance of law enforcement duties.
- Become certified in DWI detection and investigation, and become competent in illegal drug detection and reporting.
- Develop skills in law enforcement driving and vehicle stops.
- Understand problems associated with, and indicators of, gangs and organized crime.
- Apply legal and safe techniques in searches of persons, vehicles and buildings, handling hazardous materials, and responding to terrorism incidents.
- Understand and apply techniques of crime scene processing, collection, documentation and investigation; including property crimes and crimes against persons.
- Write professional police reports.
- Become certified as First Responders (First aid and medical assistance).
- Understand and demonstrate proper use of force techniques, applications, and decision making.
- Become certified in the use of expandable batons.

**MEMORANDUM OF AGREEMENT BETWEEN  
THE CENTRAL MISSOURI POLICE ACADEMY  
at UCM  
AND STATE FAIR COMMUNITY COLLEGE**

THIS AGREEMENT is entered into by the Central Missouri Police Academy at the University of Central Missouri (UCM) (hereinafter, "CMPA") and State Fair Community College (hereinafter, "SFCC").

WHEREAS, CMPA and SFCC have agreed to partner in the delivery of Peace Officer Basic Academy (Basic Academy) as established by Missouri Peace Officer Standards and Training (POST), and required of all to be become a sworn peace officer. Courses will include all mandatory POST curricula (600 hours as of the date of this memorandum), as well as supplemental blocks deemed to be beneficial and required by the CMPA, and also approved by POST.

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations in this Agreement, the parties agree as follows:

**A. Joint Responsibilities**

(1) Course Custodian and Partnering: CMPA and SFCC agree to jointly market the part time, Basic Academy program. This is the POST required, 600 hour program and additional POST approved, supplemental blocks. Supplemental blocks to be included will be determined by CMPA. These courses will be presented as a joint effort involving instruction conducted by CMPA instructors, primarily at SFCC facilities, but also including off-site facilities as necessary for specific blocks of instruction that cannot be conducted at SFCC facilities.

**B. SFCC Responsibilities**

- (1.) Reimbursement: SFCC will host the program as noted in (1) as a service to their students, and remuneration for facility use is not an expectation.
- (2.) SFCC will provide access to all SFCC facilities and will be responsible for locking the facilities at the end of each training session.
  - a. SFCC will provide names and phone numbers of alternate SFCC personnel to assist CMPA personnel in the event of emergency or other circumstances that may render the primary access person unavailable.
  - b. CMPA will not be provided keys to SFCC facilities.
  - c. Access to any off-site facilities, such as those needed

for firearms and driver training, will be arranged by  
CMPA personnel.

- d. The primary contact person for opening and closing the SFCC facilities, and equipment storage therein, will be the SFCC Criminal Justice Department Chair.

### **C. CMPA Responsibilities**

- (1) Student Fees: All student fees will be charged by, and paid to, CMPA / University of Central Missouri, in the same manner as with full-time academy students.
- (2) POST Reporting: CMPA will be responsible for maintaining all required POST documentation.

(3.) The CMPA Part-Time Academy is a 45 week academy with class meeting days on Tuesdays, Thursdays, Saturdays and some Sundays, as designated in the course schedules for each Basic Academy class. There may be a need to adjust each annual schedule depending on holidays or other events. Each Academy class schedule will be published prior to the beginning of the Academy and with prior agreement of adjustments between CMPA and SFCC.

- a. Tuesday and Thursday class sessions will be four (4) hours in duration; 6:00 – 10:0 PM.
- b. Saturday sessions will be eight (8) hours in duration; 8:00 AM to 5:00 PM and allowing one hour for lunch.
- c. Sunday sessions will be eight (8) hours in duration; 8:00 AM-5:00 PM and allowing one hour for lunch.

### **D. Party Representatives and Responsibilities**

- (1.) Each party has designated an Executive Agent for the execution of this MOA. The party representatives are:
  - a. For the Central Missouri Police Academy (CMPA) - University of Central Missouri (UCM):

  - b. For State Fair Community College (SFCC):  
Dr. JoAnna Anderson

**E. The period of Agreement, Modification, or Termination**

- (1.) **Period of Agreement:** This Memorandum of Agreement is in effect upon the signature of individuals representing both parties and will remain in effect until rescinded, revised or suspended by either of the parties.
- (2.) **Modification:** Modifications to this MOA shall have no force and effect unless and until such modifications are reduced to writing and signed by authorized representatives of the parties hereto and with at least 30 days advance notice of the intended date of modification effect.
- (3.) **Termination:** The parties hereto may terminate this MOA at will by notifying the signatories in writing. Termination will take effect within 30 days of the notice.

**F. CMPA Representative for Ongoing Administration:** The CMPA's Director is designated as the CMPA's representative for the purpose of daily administering the provisions of this Agreement. The CMPA's representative may designate, by written notice, other persons having the authority to act on behalf of the CMPA in furtherance of the performance of this Agreement.

**G. LAW OF MISSOURI TO GOVERN:** This Agreement shall be construed according to the laws of the State of Missouri. The CMPA and SFCC shall comply with all local, state and federal laws and regulations relating to the performance of this Agreement.
