5.) Describe the need for this new major including evidence of student demand for the program and market or societal need for the skills being developed.

Higher education is changing and Missouri Southern State University has the opportunity to stay ahead of the curve, through the creation of innovative graduate programs to meet the changing needs of both traditional and non-traditional students alike. The U.S. Census Bureau's Current Population Survey School Enrollment Supplement indicated the from October 2011 to October 2018, the total number of people enrolled at all levels of school declined by 2.2 million to 76.8 million people. However, during that same frame, the number of students enrolling in graduate and professional school increased by 307,000 to 4 million. Further, between 2018 and 2029, postbaccalaureate enrollment is projected to increase by 3 percent (from 3.0 million to 3.1 million students).

There are many benefits to students who continue their education post baccalaureate. In today's increasingly competitive job market, the benefits of a master's degree can help students differentiate themselves and remain valuable employees. A master's degree will help students gain specialized knowledge to help build on their current abilities, gain new skills, increase professional networking, advance in their current career path or transition to an entirely new field, and increase earning potential. According to the U.S. Bureau of Labor Statistics, jobs requiring a master's degree are projected to increase by 18 percent from 2012 to 2022. Those with postbaccalaureate degrees average 35% higher salaries than bachelor's degree holders.

However, traditional discipline specific programs may not meet the needs of today's graduate students. The Guardian has reported that the "higher education sector needs to find new structures that demonstrate we're set up in the most effective ways to wrestle with real problems." To address these real problems the most effective solution is "designing courses that are cross-disciplinary, where one discipline learns from the perspective of another, or interdisciplinary, where the disciplines are integrated, allows for more context-specific programmes [sic] that better suit industry and prepare students for jobs, opening doors rather than closing them." The Master of Science in Justice Studies is this type of innovative program, which is designed to prepare students to be job-ready and to be able to address the real-life issues facing our country today. The Master of Science in Justice Studies is an interdisciplinary partnership between multiple departments, schools, and colleges at Missouri Southern State University designed to allow students, from all disciplinary backgrounds, the opportunity to explore and gain a deeper understanding of the multiple facets of what we call "Justice." Students in this program will synthesize advanced scholarly knowledge from diverse yet interrelated fields, critique historical and theoretical concepts related to the understanding and application of justice, and master disciplinary and interdisciplinary skills essential to both scholarly and profession settings. This new degree offering is unique not only to the region, but to the country as well, and at little to no additional cost to Missouri Southern State University will provide a competitive edge against other universities in terms of recruitment and retention.
