**Program Accreditation** 



Institutional Plans for Accreditation:

The current Master of Science in Library Science program would like to become a new Master of Library Science program as part of its path to achieving American Library Association (ALA) accreditation. The program applied for and received ALA precandidacy in the summer of 2021. Becoming an MLS program is the next step towards achieving candidacy. The current MS program is in its 46th year in 2021, and has been continuously nationally recognized by AASL/CAEP/NCATE since 2002.

There are three reasons for this path from MS to MLS:

- 1. For continuous improvement and quality of the program. The program has a long history of CAEP/AASL accreditation. The faculty believe that seeking ALA accreditation is the next step for program improvement and to increase program quality.
- 2. To prepare all types of librarians. Our current program is focused on school librarianship, but our graduates are increasingly gaining employment in public, state, and academic libraries, in addition to school libraries. We are already changing our coursework to meet these needs. In addition, the faculty believe ALA-accreditation will serve our future graduates better in their careers.
- 3. At the request of our advisory council. Since 2016, our advisory council has asked us to consider applying for ALA-accreditation. At that time, the program reviewed ALAaccreditation expectations and has been making purposeful changes that have led to the first submission for precandidacy in 2021. As with all things, the pandemic delayed the program submission slightly. The faculty in the program have been steadily making changes to the curriculum, assessments, advising, advisory board, and hiring. One example was hiring Dr. Jenna Kammer in 2017, who had areas of expertise outside of school librarianship, including research and experience in public and academic librarianship. Her courses, as she has revised and developed them, reflect this.

The MLS program mission will be: The Library Science and Information Services Program at UCM disseminates knowledge that transforms students into library leaders who possess the knowledge, skills, and confidence to succeed in all types of libraries.

This is tightly related to the current UCM mission which is "disseminates knowledge that transforms students into leaders who possess the aptitudes, skills, and confidence to succeed.

According to the Bureau of Labor Statistics employment of librarians is projected to grow 5 percent from 2019 to 2029, faster than the average for all occupations.

The societal need for librarians is consistent in that most towns, schools, and universities have libraries and need librarians to develop the collections, work with patrons, and manage the library spaces.

There is no other program at UCM that prepares librarians.
