**Background**

Missouri's Big Goal for Higher Education is to have 60 percent of working-age adults with a high quality certificate or degree by 2025. In order to meet this goal, a significant number of adults will need to be trained.

The effectiveness of the total suite of financial aid programs was reviewed during a comprehensive look at the Missouri state financial aid programs in 2018. Right now, Missouri only has two financial aid programs serving adult students – the Access Missouri Grant and the Marguerite Ross Barnett Memorial Scholarship. The Ross Barnett scholarship serves about 200 students a year with a \$400,000 appropriation. Fast Track would help address this issue, potentially serving 13,000 students, and putting Missouri among leading states that are serious about serving adults.

**Opportunity**

- Fast Track will increase financial access, encouraging students to enter areas with workforce shortages by providing financial aid to cover actual tuition and general fees.
- This program will open doors for an entire segment of the population to get training and participate meaningfully in the workforce.

Demand on state funds will be reduced by using federal aid, including Pell Grants and Workforce Innovation Opportunity Act funds, first.

**Potential Impact**

- Adults with no postsecondary education – Someone who is underemployed or whose economic situation has changed due to a lay-off or personal circumstances.
- Adults who have some college but no degree – Someone who may have entered college right after high school but never finished.
- Adults with an associate degree – Someone who needs an additional credential to move up to a better job.

## Fast Track Eligibility

Fast Track eligibility will be restricted to instructional programs that lead to employment in high-need occupations as designated by the Coordinating Board for Higher Education (CBHE). Public comment is being collected until May 15, 2019, on a preliminary list of high-need occupations and program categories. ### How the list was developed

The MDHE identified high-demand occupations using long-term occupational projections developed by the Missouri Economic Research and Information Center (MERIC). MERIC's projections assign career grades based on projected openings, growth, and wages. Occupations were included if they had a grade of A or B at the state level or in any region. Occupations were then excluded if they typically required no formal education or education above a bachelor's degree, or had below average projected total job openings.

High-demand occupations were then linked to academic programs (identified by a four-digit Classification of Instruction Programs [CIP] code) using a nationally standardized crosswalk of Standard Occupational Classification (SOC) to CIP codes. A program that linked to a high-demand SOC code was included. The CIP codes will identify programs eligible for Fast Track.
